Cookies

To make this site work properly, we sometimes place small data files called cookies on your device. Most big websites do this too. A cookie is a small text file that a website saves on your computer or mobile device when you visit the site. It enables the website to remember your actions and preferences (such as login, language, font size and other display preferences) over a period of time, so you don't have to keep re-entering them whenever you come back to the site or browse from one page to another.

How do we use cookies?

When someone visits www.calu.edu, internal servers automatically collect and store limited information about the visitor's computer connection to the Internet. The information collected allows California University of Pennsylvania (Cal U) to make the site more useful to visitors.

Cal U does use the following types of cookies:

Strictly Necessary

- Javascript session cookies to maintain an anonymous user session by the server.
- Microsoft ASP-based technologies to maintain an anonymized user session.
- Amazon load balancing functionality.

Performance-Based

- Google Analytics to user track user behavior, session and campaign data. This does not contain any personally identifiable information. Data is used to analyze website traffic and make improvements to www.calu.edu.

Targeted Advertising

Cal U advertises with Google Remarketing, displaying ads across the web to users who may have visited the Cal U's website in the past or have shown interest in specific information within the site. Cal U also advertises with or has cookies associated with Facebook.com, Twitter.com, Tapad.com, and AddThis.com.

Cal U utilizes cookies to track information unique to each visitor including pages visited and past site activity in order to provide better service when users return to the site as well as provide a better user experience in the future.
